

# My Health My Data Privacy Policy

## Quick Weight Loss Shop (QWLS)

This notice is intended to supplement the Quick Weight Loss Shop (“QWLS”) Privacy Policy and applies to personal data defined as “consumer health data” under the Washington State My Health My Data Act (“MHMD”).

This policy applies solely to individuals who are Washington State residents or whose data is otherwise subject to MHMD.

## Consumer Health Data We Collect

The consumer health data we collect depends on the context of your interactions with QWLS, the choices you make (including privacy and cookie settings), the products and features you use, your location, and applicable law.

Because “consumer health data” is defined broadly under MHMD, some of the categories of personal data we collect may also qualify as consumer health data.

As described in the “Information We Collect” section of our Privacy Policy, we primarily collect data that you choose to provide to QWLS, information generated through your use of our Services, and information collected based on your privacy preferences and geographic location.

Examples of consumer health data may include:

Information regarding your health-related conditions, symptoms, status, diagnoses, testing, medications, allergies, or treatments, including prescription history or laboratory-related information, when provided by you in connection with your use of our Services. For example, if you seek to connect with an independently licensed healthcare provider for a metabolic health evaluation or prescription assessment, we may collect certain health-related information necessary to facilitate those services.

Precise location information that could reasonably indicate your attempt to obtain or receive healthcare services or supplies.

For example, if you consent to analytics or location-based services through your cookie preferences, we may collect limited location data to determine whether a provider licensed in your state may offer services.

Information that could reasonably indicate your attempt to seek healthcare services or information, including interactions with features that allow you to explore, assess, or learn about health-related topics or treatment options.

Other information that may be used to infer or derive health-related data from the categories described above.

#### Sources of Consumer Health Data

As described in our Privacy Policy, QWLS collects personal data (which may include consumer health data):

Directly from you when you create an account, complete forms, or communicate with us

Through your interactions with our Website and Services

Through cookies and similar technologies, only where you have provided consent through our Cookie Consent tools

QWLS does not collect consumer health data through cookies without your explicit consent.

#### Why We Collect and Use Consumer Health Data

We collect and use consumer health data for the purposes described in the “How We Use Your Information” section of our Privacy Policy, including:

Facilitating access to telehealth services

Enabling communication with independently licensed healthcare providers

Supporting prescription fulfillment through licensed pharmacies

Responding to inquiries submitted through our Contact Us features

Maintaining security, compliance, and platform functionality

Where required by law, we obtain your affirmative consent prior to collecting, sharing, or otherwise processing consumer health data.

You may review the “Your Choices” and “Your Rights” sections of our Privacy Policy for additional information regarding available controls.

#### How We Share Consumer Health Data

We may share consumer health data only as described in our Privacy Policy and as permitted or required by law.

In particular, we may share such data:

With your consent

At your direction

As reasonably necessary to provide the Services you request

To comply with applicable law or valid legal process

This may include sharing information with independently licensed healthcare providers or licensed pharmacies located in your state, when necessary to facilitate care or prescription fulfillment.

**With Whom We Share Consumer Health Data**

QWLS may share consumer health data with the following categories of third parties, solely for the purposes described above:

**Healthcare Providers**

Independently licensed physicians and healthcare professionals who use the platform to provide services you request.

**Pharmacy Partners**

Licensed pharmacies that dispense and ship prescriptions issued by your provider.

**Service Providers**

Vendors, contractors, or agents (“processors”) who assist with data security, infrastructure, communications, analytics (where consented), or operational support.

**Corporate Transactions**

In connection with a merger, acquisition, financing, bankruptcy, dissolution, or transfer of assets, subject to applicable confidentiality protections.

**Government Authorities**

Where required to comply with applicable law, regulation, subpoena, or valid legal process.

**Affiliates**

Subsidiaries or affiliated entities that share common systems or operational support, solely to enable delivery of Services.

QWLS does not sell consumer health data.

## How to Exercise Your Rights Under MHMD

QWLS requires affirmative consent for the collection and sharing of consumer health data, as required by MHMD.

Under the My Health My Data Act, Washington consumers have the right to:

Access consumer health data

Request deletion of consumer health data

Withdraw consent for future collection or sharing of such data
